# THE SMITHFIELD TOWNSHIP BOARD OF SUPERVISORS WORK SESSION DECEMBER 9, 2020

A Work Session of the Smithfield Township Board of Supervisors was held on December 9, 2020, at the Smithfield Township Municipal Center, at 1155 Red Fox Rd, East Stroudsburg, PA 18301, and via Zoom due to the COVID-19 pandemic.

#### 2. New Business:

a. Shawnee Valley 2020 Annual PRD Update. Kurt Williams of Salzmann & Hughes states COVID-19 has seriously impacted development and is asking for one-year extensions on development schedules for the Shawnee Valley PRD.
