## THE SMITHFIELD TOWNSHIP BOARD OF SUPERVISORS REGULAR BUSINESS MEETING JANUARY 3, 2023

A Regular Business Meeting of the Smithfield Township Board of Supervisors was held on January 3, 2023, at the Smithfield Township Municipal Center at 1155 Red Fox Rd, East Stroudsburg, PA 18301, and via Zoom.

Present are Supervisors Jacob Pride, Robert Lovenheim, and Brian Barrett (via Zoom), and Jon Tresslar of LVL Engineers. Township Manager Julia Heilakka and Solicitor Ronold Karasek are excused.

- 1. Chair Jacob Pride calls the meeting to order at 6:17PM. A quorum is present.
- 2. The Pledge of Allegiance was recited at the Reorganization Meeting preceding the Regular Business Meeting.
- 3. Announcements none.
- 4. Minutes.
  - a. Jacob Pride motions to approve the minutes from the December 21, 2022 Regular Business Meeting, Robert Lovenheim seconds. Vote: all in favor; motion carries.
- 5. Reports.
  - a. Solicitor's Report none.
  - b. Engineer's Report Jon Tresslar informs the Board that construction at Smithfield Gateway for the St. Luke's building is winding down. The developer is requesting the punch list inspection. Jon Tresslar expects a new plan from Smithfield Gateway in the near future. Brian Barrett discusses recent accidents near the proposed traffic signal. Jon Tresslar believes PennDOT has granted St. Luke's permission to open with a stop sign. The Board expresses safety concerns, discusses the PennDOT debate regarding computer software for traffic signals, and the Green Light Go program.

Robert Lovenheim motions to approve the contribution, Jacob Pride seconds. Brian Barrett asks how much the contribution is for, Jacob Pride states the balance of the FY2022 budgeted contributions which is \$1,000.00.
