### **General Overview**


1. Smithfield Township's millage rate is the 12<sup>th</sup> lowest in Monroe County:

3. East Stroudsburg Area School District maintains its status as the bulk of your local taxes – their current millage rate (2023) is 30.79 mills.

#### **Fire/EMS Tax Creation**

- 1. EMS Providers for Smithfield Township:
  - a. Bushkill EMS (based in Middle Smithfield Township and Smithfield Township)
  - b. Suburban EMS (based in Stroud Township)
- 2. Since June 2023, Smithfield Township has approved a monthly emergency payment of \$11,160 to Bushkill EMS to keep the emergency service functioning. If Smithfield Township stops these emergency payments, Bushkill EMS is in danger of closing its doors. The creation of this tax creates a sustainable funding stream so residents continue to receive EMS coverage from a nearby provider. The next closest EMS provider is Suburban EMS, out of Stroudsburg.
- 3. Fire Providers for Smithfield Township:
  - a. Delaware Water Gap Fire Company
  - b. Marshalls Creek Fire Company
  - c. Shawnee Fire Company
- 4. All fire companies that serve the Township are volunteer organizations. Decreasing donations and rising costs of trucks mean the fire companies are in danger of not being able to afford to operate in the coming years. To prevent fire coverage from being threatened as EMS is now, the fire tax creates a funding stream that will permit fire companies to sustainably replace vehicles and equipment needed to preserve the life safety of residents and firefighters.

### Municipal Millage Increase

- 1. Smithfield Township increased the millage because previous Boards saved to pay off the Township's bond, but in doing so, pushed off equipment repairs and replacement. This has placed the Township in a position where Township equipment is failing, and there were inadequate funds set aside to cover the purchase of new equipment.
- 2. Smithfield Township's millage increase covers:
  - a. Establishment of a Capital Improvements & Grants Fund, creating a consistent contribution to replace failing and failed equipment
    - i. Includes purchase of a loader (required for loading trucks with salt)
    - ii. Includes purchase of a skid steer (for road paving and maintenance)
  - b. Increases in personnel, to bring equipment repairs in-house, increase grant funding applied for, increase park and environmental stewardship, increase Township outreach through social media and other digital applicants, and support zoning administration.
- 2. Smithfield Township staff work will lead to a gain of ~\$368,000 in reimbursables due to the Township from awarded grants.
